What we collect

We may collect the following information:

- Name
- Company Details
- Phone Number
- Email Address
- Appropriate details of what your matter entails

What we do with the information we gather

We only require the details stated above to be captured if you choose to submit an enquiry via the Contact Us enquiry form.

We will not share your personal information with third parties without your permission or unless required to provide our services to you, other than for the limited exceptions listed below:

- In urgent circumstances to protect the personal safety or vital interests of clients or the public; or
- For the purposes of our legitimate interests or those of a third party, but only if these are not overridden by your interests, rights or freedoms.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.
